

Using real-time benefit check tools saves your practice time — and your patients money.

#### What you should know about real-time benefit check:

- This tool is already in many EMR platforms. Simply ePrescribe a new medication, and your real-time benefit check tool will automatically run a trial claim.
- If you use an EMR where this tool is not yet embedded, use your OptumID to access real-time benefit checks.

- You enter a medication.
- The benefit check tool runs a real-time, member-specific trial claim and checks the patient's benefit plan for current prescription coverage and prices, as well as possible medication alternatives to consider.
- An alert will display if the prescribed medication requires a prior authorization, if it's not preferred or if there is a supply limit issue.

#### **How it improves adherence:**

- Since OptumRx launched PreCheck MyScript (PCMS), we have found significant improvements in medication adherence rates for three chronic conditions:
  - Diabetes: 4% improvement
  - •Statins: 4% improvement
  - Hypertension: 2% improvement

How to start ePrescribing:

- Add the Optum Specialty Pharmacy profile in your EMR system to send the prescription directly to us.
- Verify your EMR software is certified for ePrescribing controlled

substances (EPCS).

How to submit an ePrescription

- If needed, submit a prior authorization request using your preferred electronic prior authorization portal, such as CoverMyMeds<sup>®</sup>.
- Submit the ePrescription to Optum Specialty Pharmacy.

# ePrescribing

#### What is ePrescribing


- ePrescribing provides efficiency and safety of prescription, while decreasing costs and improving quality of care of our members at point of care
- Provides complete, accurate and clear prescription orders via electronically by providers directly to a patient choice of pharmacy
  - Removes delay in patient care, fast and time saving, convenient
  - Accurately and efficiently provides eligibility, drug therapy and other necessary data
    - Eliminates many common medication errors ahead of time
  - Permits lower cost drug substitutions by improving formulary adherence
    - Provides saving opportunities to member and payers
  - Allows automated of Electronic Prior Authorization process that helps both the prescriber and pharmacist
    - Reduce member medication disruption, adheres to ePA state mandates, ease the burden for providers and pharmacies

#### How ePrescribing Works

ePrescribing is the electronic transfer of prescriptions by Providers directly to a pharmacy.

- OptumRx uses a network provided by SureScripts that links PBMs, Health Care Providers and Pharmacies.
- SureScripts has certified our claims, eligibility, and medication history system/processes for ePrescribing purposes. SureScripts also serves as a network routing solution for transmitting ePrescribing communications between PBM, EMR and pharmacy.
- OptumRx sends Formulary and Membership files to SureScripts via an automated scheduled process once initial set up of an eProfile is completed.
- Eligibility is monitored & updates are sent daily to SureScripts for their Master Patient Index (MPI). Eligibility includes basic demographic data for look-up purposes (gender, name, DOB). Eligibility check is done to determine if the member is covered and the formulary file has basic information about which drugs are / are not covered by the plan.
- Prescribers use a computer or handheld device which allows them to access patient eligibility
  and medication history (list of dispensed medication). Prescribers can also route the
  prescriptions to the patient's choice of pharmacy. SureScripts requires the consent process with
  the EMRs. This is handled between the doctor, EMR and SureScripts.




